- Successful solutions and applications that maintain and improve the production cycle fostering a long-lasting circular economy.

## CRITERIA FOR EVALUATION

#### **Innovation**

- Radical innovation (new product unknown to the market using latest technology).
- Continuous innovation (improvement in the existing product).

### **Market feasibility**

Evaluation of various market factors to determine the product's viability for commercialization.

### Integration of new technologies

The incorporation of new technologies to drive significant improvements to competitiveness.

# **Increased production** and/or distribution efficiency

The aim is to use as few resources as possible to generate more.

### **Energy efficiency**

Improving energy efficiency has become a critical factor in the processes, companies have seen the need to move along with new technologies as it is one of the main tools with which to achieve increased productivity and production cost savings.

#### Sustainability, waste, circular economy

A smart, innovative and sustainable plastics industry, where design and production fully respect the needs of reuse, repair and recycling.

- 1) All information provided by participants will be handled with the utmost confidentiality until the registered proposals are published in February 2025.
- 2) By participating, the contestants agree to abide by the rules and accept that the jury's decision is final and not subject to appeal.
- 3) The proposal must include:

  - **b. Description** of the functions/mechanisms and benefits of the project (300 words, text in Times New Roman, font size 11).
  - c. Information on the approximate cost of investment and operation.
  - e. Video of no more than 90 seconds showing the application and operation of the submitted work. A YouTube link must be submitted.
  - f. Three images of the project in high resolution (minimum 300 dpi).
- 4) Submissions that do not comply with the registration procedure described above will not be considered.
- 5) The nominees will be notified directly by the organizers in February. Nominees are prohibited from disclosing their nomination to other participants prior to the official announcement at PLASTIMAGEN® MEXICO.

#### **THE JURY**

The qualifying jury consists of distinguished professionals and industry experts who will carefully evaluate all submissions and identify three works as nominees for the award according to their category.

- The jury will convene at the end of February 2025 to make the final evaluation and selection of the nominees.
- The jury may reassign a proposal to a different category if it deems the original placement inappropriate.
- If the jury considers that the proposals do not meet minimum quality requirements, the award may be declared void.
- The decision of the jury is final and not subject to appeal.
- Any matters not addressed in this call for papers will be resolved by the organizers.
